If the applicant believes its appeal aligns with provisions in NCGS 160D-405(f), the applicant may file with the Town a request for an expedited hearing of the appeal, and the BOA shall meet to hear the appeal within 15 days after such a request is filed.

The complete application and all evidentiary materials that parties intend to introduce to the BOA at the hearing must be delivered to the BOA 10 calendar days prior to the hearing date to be considered at the hearing.
